## PLEASE READ CAREFULLY BEFORE SIGNING!

I, the undersigned, in consideration of renting a Segway PT from 2 Wheel Tours and Fun LLC, DBA Granbury Segway, or participating in a Segway PT tour, state that I have read and understand and hereby expressly accept and agree to the following:

A. **Risk of Personal Injury**. I understand that the risks of riding or touring on a Segway are numerous and include, but are not limited to, the following: DEATH, PARALYSIS, HEAD INJURIES, BROKEN BONES, CUTS, SCRAPES, DAMAGE TO SEGWAYS, GEAR AND CLOTHING, AND DAMAGE TO AND/OR INJURY TO OTHERS; falling, loss of control; problems loading, unloading or riding the Segway; encountering trees, limbs, brush, rocks, structures, ropes, barriers, and/ or other man made or naturally occurring obstacles; encountering unpredictable terrain such as varying steepness, mud, holes, cliffs, gravel, narrow trails, and/or lack of trails; negligence of other riders, persons, or vehicles; and/ or negligent actions of 2 Wheel Tours and Fun LLC, its employees, its tour guides, any owners of property ridden on, their officers, employees, or agents (here in collectively referred to as "2 Wheel Tours and Fun"). I understand that risks from riding may include encountering bicycles, other Segways, motor vehicles, motorcycles and other motorized vehicles that may pose a hazard to me while riding the Segway in an urban environment. I understand that the risk of injury can increase due to inclement weather such as, but not limited to, snow, rain, hail, heat, and high winds. Injury can also occur due to inclement weather such as, but not limited to, heat exhaustion from extreme heat, frostbite from cold, and other injuries from rain, hail, snow, or other weather conditions.

## B. Conditions and Representations.

- I have made no misrepresentation to 2 Wheel Tours and Fun in any regard, including, but not limited to, my height, weight, age or abilities. PREGNANT RIDERS SHOULD NOT PARTICIPATE FOR SAFETY REASONS. I understand that a rider must weigh between 100 and 260 pounds and must be at least 14 years of age.
- 2. All instructions for use of the Segway or other equipment (the "Equipment") have been made clear to me and I fully understand how to use the Equipment. I accept the Equipment for use as is, and accept full responsibility for the care of the Equipment while it is in my possession.
- 3. I have watched the online safety video and understand how to operate the Segway in a safe manner.
- 4. I have a helmet, or one has been provided to me and I will wear a helmet at all times. I understand that wearing a helmet may decrease my risk of head injury.
- 5. The Segway is working properly. I am physically and mentally able to ride the Segway and I am familiar with riding and its physical and mental requirements and risks involved.
- 6. I will read and follow all instructions and signs. I agree that 2 Wheel Tours and Fun may revoke my right to ride and prevent my issue of the Segway without refund for unsafe or rude conduct and/or failure to obey instructions.
- 7. I am aware of the costs associated with Segway damage including but not limited to the price for a new machine, batteries, grips, handlebars, shaft, wheels, wheel covers, and fenders. I agree that I assume responsibility for complete replacement for any and all damage done to the Segway due to my own misuse, accidents, other riders, or if lost or stolen and / or any other circumstances.
